





Letter From the Chief Executive Officer

Dear Friends,

Thanks to the team efforts of the Board of Directors and Health Center staff, as well as the unwavering support of our community, Battenkill Valley Health Center (BVHC) achieved many milestones since its opening on February 27, 2014.

- We closed our first fiscal year on June 30, 2014 with a strong positive bottom line and a successful independent financial audit.
- Our clinical team, including the Blueprint for Health providers, welcomed 2,241 new patients and managed 12,378 patient visits during our first 15 months of operations.
- Our management team replaced antiquated clinical and office equipment with new technology including networked computers with a dedicated mainframe as well as a state of the art telephone system.
- We underwent an intensive, two-day program audit by a three-member team from Health Resources and Services Administration (HRSA), receiving favorable reviews.
- In partnership with the Town of Arlington and community supporters, we began the quest to create a modern
 wellness campus to house a new clinical building offering improved access to medical, behavioral health and
 dental services the Community Cares Building Project.

Success can be measured in many ways: access to care, quality of care, patient satisfaction, and financial stability to name a few. These and other measures are summarized in this, our first annual report. I encourage you to read the report with the knowledge that the outcomes in the report would not have been possible without your support.

BVHC's Board of Directors, management team and staff remain energized and committed to our mission to ensure Bennington County residents in our service area have access to primary care services. We welcome your continued support and look forward to sharing future successes with you.

A Story of Care: Nancy Tschorn



Residents of Sandgate, West Arlington and surrounding communities have long relied on the old-fashioned conveniences of the Wayside Country Store, offering customers everything from deli sandwiches to camping items.

Proprietors Doug and Nancy Tschorn, who bought the store in May 1984, quickly became fixtures in the community and eventually entrusted their primary care needs to Dr. Michael Welther under the former Arlington Family Practice.

When Doug became ill with cancer, those whom he and Nancy served throughout the years did not hesitate to show their support and reached out in whatever ways they could. This included the providers and staff at Battenkill Valley Health Center.

"My husband passed away in December. The people were just wonderful. They were so caring, so concerned, not only about my husband, but about me and my family. It was huge because nobody can go through that alone and these people, kind of literally and figuratively, held my hand. It was very nice to have that contact and that care," she said.

Mrs. Tschorn said that she is proud Battenkill Valley Health Center prioritizes the individualized care its patients need.

"We are a rural community, we are beginning to be a bit of an aging community. To have people in town with close access that kind of get what we're all about...we know them, they know us."





Sliding Fee Program

What is the Sliding Fee Program? The Sliding Fee Program is a federally-funded program that provides a discount to patients who are uninsured or underinsured. This program allows qualifying patients to receive provider office services at Battenkill Valley Health Center (BVHC) at a discounted fee after any insurance, if applicable, has processed the claim. There is a minimum copayment due at the time of services for all discounted services received.

Who is eligible for the Sliding Fee Program? Uninsured and underinsured patients may qualify for the Sliding Fee Program. Federal guidelines require us to take household size and income into consideration when determining an applicant's eligibility.



Community Cares Building Project

We live in exciting times. It seems that nearly every day we learn of new advancements in health care. Innovative medical, behavioral health and dental treatments, in combination with the tried and true, are helping people live longer and healthier lives. How these treatments are delivered must keep pace in order to ensure rural communities, like Bennington County, have access to the same cutting edge care afforded more populated areas.

The Community Cares Building Project is a partnership between the Town of Arlington and Battenkill Valley Health Center (BVHC). The town is leasing property to BVHC, which in turn is developing a wellness campus to house a 11,399-square-foot clinical building with the infrastructure necessary to offer advanced health care. Services will include medical, behavioral health and a new dental clinic offering a wide array of preventative and restorative oral care as well as cosmetic services. Access to innovative services such as telehealth specialty and subspecialty care and alternative medicine, e.g. therapeutic massage will ensure BVHC patients receive modern day care in the comfort of their own community.

Through a rigorous request for proposal (RFP) process, BVHC selected ReArch Company LLC and Tyler Scott of Scott and Partners Architecture in April of this year to design and oversee the construction of the Community Cares Building. ReArch, which has a client roster that includes Ben & Jerry's, Fletcher Allen Health Care and Community Health Centers of Burlington Inc., will work in tangent with local businesses and trades people to complete the new building by February 2017.

As a federally qualified health center (FQHC), BVHC operates under Health Resources and Services Administration (HRSA); our charge is to care for all people regardless of their ability to pay. FQHCs operate on lean budgets, so funding for initiatives like the Community Cares Building Project rely on grant funding, loans and community benefactors and supporters.

BVHC is poised to launch a Community Cares Building Project capital campaign to help cover the cost of this important initiative. Contributions, big and small, will be vital to our success. 
